EITS Contractor undertaking the **Telecommunications & Security Systems scope** on the EACOP project, invites experienced and reputable firms to express their interest in the Provision of Technical Assistance Services (Technical Manpower: Fiber Optic technicians, Field items Technicians, Helpers, Tools & Testing equipment) for supervising installation, Hookup, testing and commissioning activities for Telecom and security systems.

EACOP = East Africa Crude Oil Pipeline Project

EITS = Electrical, Instrumentation, Telecommunication and Security Systems

SCOPE OF SERVICES:

Assistance in Installation

Confirm that the construction company has installed EITS Telecom & security equipment according to approved drawings and method of statement with all safety and technical requirements, such as Network cabinets; CCTV, ACS, PAGA, VHF, metocean, telephony, WIFI, IDS, JB, cable glands etc...

Hookup

- **Mechanical installation and power connection of active equipment:** Network switches, servers and routers, telecom gateways, amplifiers, power units...
- **Telecom cabinet adaptation:** Power cabinet modification, electrical safety tests, circuit testing, patching...
- **Cabling and Termination:** Pulling of incoming cables to network cabinets, cable gland installation and cable termination and splicing (CCTV, PAGA, ACS, Telephony, WIFI, VHF, IDS, Metocean...)
- Fiber optic splicing (up to 96 cores) (only for some profiles)

Pre-commissioning & commissioning

Testing activities for Low voltage cable, communication cable (FOC, Ethernet etc...) and control system cables,

for outdoor equipment and testing assistance for Telecom networks and systems.

- Functional test
- Operational test
- End to end test.

MINIMUM REQUIREMENTS:

- Proof of business registration and business license for Tanzania
- Proof of registration with the Tanzania Revenue Authority (TRA) (TIN and VRN) and Tax Clearance Certificate (TCC) for the latest year available.
- Proof of Tanzania Tax Clearance Certificate for the latest year
- Proof of registration/application to Local Supplier Service Provider (LSSP) database at the time of submission of the response to this expression of interest is strongly recommended
- Compliance with Petroleum (Local Content) Regulations, 2017 and Local Company definition for Tanzania
- Provide financial statements for the past 3 financial years.
- ISO 9001, ISO14001, ISO 45001 & Industry Certification(s)
