

REQUEST FOR EXPRESSION OF INTEREST: SUPPLY OF AUTOMOTIVE GAS OIL (DIESEL) FOR FIELD OPERATIONS REFERENCE REQ-00000906

East African Crude Oil Pipeline (EACOP) Limited ("COMPANY") invites experienced and reputable companies or organizations to express their interest in the Supply of Automotive Gas Oil (Diesel) for Field Operations.

The EACOP Project involves the construction and operation of an underground and cross-border pipeline to transport crude oil from Lake Albert area in Uganda to eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani peninsula in Tanga, Tanzania. The length of the pipeline is 1,443 km, of which 296km will be in Uganda and 1,147 km in Tanzania. In Uganda the pipeline will traverse ten (10) districts and eight (8) regions comprising of Kagera, Geita, Shinyanga, Tabora, Singida, Dodoma, Manyara and Tanga, 27 administrative District Councils, and 231 Villages in Tanzania.

BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES

COMPANY invites experienced and qualified Ugandan suppliers to express their interest in the supply and delivery of Automotive Gas Oil (AGO - Diesel) for the Operations Phase of the EACOP Project covering the entire pipeline route and associated facilities across Uganda.

PRODUCT SPECIFICATION

Automotive Gas Oil (AGO) conforming to local regulatory standards and EACOP quality requirements. including: Sulphur content ≤ 50 ppm (Euro 4/5 compliant); Cetane Number ≥ 51 ; Density at 15°C : 820-845 kg/m²; Cloud points suitable for local climatic conditions; Free from contamination (water, sediments, microbial growth); Certified test results from an accredited laboratory per batch.

DELIVERY LOCATIONS

- Pumping Stations (PS 1 in Hoima and PS 2 in Sembabule).
- Mobile refuelling for operational fleet at remote sites (as required).

DELIVERY REQUIREMENTS

- Supply in bulk via road tankers compliant with Accord Dangereux Routier (ADR) regulations and in-country regulations.
- · Tankers to be equipped with calibrated meters and seals.
- Delivery schedule: 24/7 capability, with emergency supply arrangements.
- Supplier to maintain strategic stockholding to ensure uninterrupted operations.

MINIMUM REQUIREMENTS

Companies, organizations or local joint ventures expressing their interest are invited to document their request with:

- Company Profile including organization structure and contact details.
- Certificate of Registration or Incorporation and Ownership details including Beneficial Owners Particulars (URSB Form 1) and Appointment of Directors (URSB Form 20). (attach copies).
- Brief description of experience in undertaking similar supplies, expertise in delivering the required scope of services.

- · Details of storage facilities, fleet size, and distribution network.
- Evidence of previous and ongoing projects, supplies contracts including references from past and current clients which provide evidence of qualified and available team, and track record of the above-listed experience.
- Valid business license including copies of all relevant certifications for the supply of products required.
- Proof of registration with the Uganda Revenue Authority (URA) and Tax Clearance Certificate for the latest year available.
- Proof of up-to-update Registration with the National Supplier Database (NSD) maintained by the Petroleum Authority of Uganda
- Compliance Statement with the Petroleum (Refining, Conversion, Transmission and Midstream storage) (National content) Regulations, 2016 and Ugandan Company definition.
- Bank confirmation letter of financial capacity including submission of audited financial accounts for the past three years.
- Evidence of Anti-corruption, Anti-bribery, Compliance, and Human Rights policies.
- Evidence of a Quality Health, Safety, and Environment (QHSE) Management system, organization, and process in compliance with applicable Local and Industry standards for similar works including incident history for the past three years.
- ISO 9001 (Quality Management), ISO 14001 (Environmental), and ISO 45001 (Occupational Health & Safety) certifications preferred.
- Any joint venture/partnership arrangements (if applicable).
