



REQUEST FOR EXPRESSION OF INTEREST: PIG SUPPLY AND SUPPORT SERVICES REFERENCE NO. REQ-00000909

East African Crude Oil Pipeline (EACOP) LTD invites experienced and reputable companies or organizations to express their interest in the Provision of Pig Supply and Support Services to EACOP Project for the Uganda perimeter.

The EACOP Project involves the construction and operation of a buried and cross-border 24-inch pipeline to transport crude oil from Lake Albert area in Uganda to eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani peninsula in Tanga, Tanzania. The length of the pipeline is 1,443 km, of which 296 km will be in Uganda and 1,147 km in Tanzania. In Uganda, the pipeline has 2 pumping stations along its length. In Tanzania, the pipeline has 4 pumping stations and 2 pressure reduction stations along its length before terminating in a Marine Terminal at Tanga.

BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES

In EACOP, pigging is carried out by running pigs through the EACOP pipeline for the purpose of cleaning the pipeline by removing wax deposits, debris and any accumulated water. EACOP is seeking a suitable and experienced pigging services company to supply pigs to EACOP and provide associated pig services for the Uganda perimeter during the start-up and operations phase of the EACOP asset. The scope includes:

- **Pig products supply**
 - » 24-inch pigs and pigging poles are required to be supplied to EACOP warehouse in Hoima, Uganda.
 - » **Pigs:** Pig types required by EACOP asset are bi-directional pigs and foam pigs. The bi-di pigs should have replaceable accessories such as polyurethane guide discs, seal discs, spacer discs, tracker, bumper nose, with and without jet function, brushes and magnets.
 - » **Pigging poles:** The pole to assist retrieving the pig from the barrel and pushing the pig into the barrel for launching.
- **Provision of pigging support services**
 - » **Purchase of accessories for pig refurbishment:** The service provider is expected to procure stock of pig accessories and keep at his premises for possible refurbishments of EACOP pigs. This is to ensure that accessories are readily available when needed.
 - » **Used pigs re-evaluation:** The service provider will inspect and re-evaluate the used pig after each run to determine the suitability for re-using, refurbishment or scrapping. The service provider will pick up the used pigs from pumping station 1 in Hoima for re-evaluation.
 - » **Refurbishment of used pigs:** Re-evaluated pigs identified to have damage of replaceable parts are refurbished with accessories in stock and returned to EACOP.
 - » **Scrapping of damaged pigs:** Re-evaluated pigs identified to have damage that is beyond repair are properly scrapped and disposed of in line with EACOP waste management requirements.
 - » **Provision of technical support service for stuck pig cases:** The service provider will provide technical support for scenarios of stuck pig.

- » **Training:** Both practical (on site) and refresher pigging training is to be provided to EACOP personnel as needed.

MINIMUM REQUIREMENTS

Companies, organizations or local joint ventures expressing their interest are invited to document their request with:

- Brief description of experience, expertise, and capacity to deliver the required scope of services.
- Experience of providing services to the oil and gas industry.
- Details of similar projects or activities undertaken.
- Provide evidence of qualified and available team, pigs manufacture capability, knowledge of pig services, and track record of the above-listed experience.
- Valid business license (attach copy).
- Certificate of registration or incorporation and ownership documents (attach copy).
- Proof of up-to-date registration with the National Supplier Database (NSD) maintained by the petroleum authority of Uganda. (attach copy)
- Compliance statement with the petroleum (refining, conversion, transmission and midstream storage) - (National content) regulations, 2016 and local company definition.
- Proof of registration with the Uganda Revenue Authority (URA) and tax clearance certificate for the latest year available.
- Financial capacity to deliver the services required including submission of financial accounts for the past three years.
- Quality Health, Safety, and Environment (QHSE) management system, organization, and process in compliance with applicable local and industry standards for similar works.
- Proof of anti-corruption, anti-bribery, compliance and human rights policies.

Companies or organizations with the ability, capacity, and resources to implement the activities listed above should express their interest by sending an Expression of Interest (EOI) via email, together with the above listed documents to procurement.ug@eacop.com (max. email size 20Mb) on or before 17:00 hours East African Time (EAT), 31st October 2025. (Email subject shall be: REQ-00000909-Pig Supply and Support Services.) Statements of EOI should be no more than twenty (20) pages long. All Expression of Interests should be submitted in the English Language.

NOTE: EACOP LTD will review and assess the documents provided by companies that have expressed interest in accordance with this EOI and conduct evaluations based on internal criteria to determine which companies, or local joint ventures will be included in the list of pre-qualified companies or local joint ventures. Only the pre-qualified companies or local joint ventures will receive, by signing a Non-Disclosure Agreement (NDA), an invitation to bid as a continuation of the call for tender process. EACOP LTD reserves the right at its sole discretion to make the decision to select or reject a company or local joint ventures and maintain its decision without having to give reasons to the company or local joint ventures concerned.
