

# REQUEST FOR PROPOSAL/EXPRESSION OF INTEREST: PIG SUPPLY AND SUPPORT SERVICES - TANZANIA REFERENCE NO. REQ-REQ-00000908

East African Crude Oil Pipeline (EACOP) LTD ("EACOP LTD") invites experienced and reputable companies or organizations to express their interest in the Pig Supply and Support Services for the Tanzania perimeter of the EACOP Project during the pipeline operations phase.

The EACOP Project involves the construction and operation of a buried and cross-border pipeline to transport crude oil from Lake Albert area in Uganda to eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani peninsula in Tanga, Tanzania. The length of the pipeline is 1,443 km, of which 296km will be in Uganda and 1,147 km in Tanzania. In Uganda the pipeline will traverse two (2) regions which are Western and Central regions and in Tanzania, eight (8) regions comprising of Kagera, Geita, Shinyanga, Tabora, Singida, Dodoma, Manyara and Tanga, 27 administrative District Councils, and 231 Villages.

# BRIEF DESCRIPTION:

In the EACOP pipeline, pigging operations will be conducted by running pigs through the pipeline to ensure pipeline integrity and flow assurance. The primary purposes of pigging are to:

- Remove wax deposits that accumulate on the internal pipeline walls.
- · Dislodge and clear debris or foreign materials.
- · Remove any accumulated water within the line.
- These activities are essential during start-up and operational phases to maintain safe, efficient, and uninterrupted transportation of crude oil.

### SCOPE OF SERVICE:

This Expression of Interest (EOI) seeks to identify qualified and experienced pigging services company to supply pigs and provide associated pigging services during the start-up and operations phase of the EACOP project. Services are required for the Tanzania perimeter and will cover both equipment supply and technical support. Services required include, but not limited to:

# 1. Supply of Pigging Products:

Pigs (24-inch):

- Supply of bi-directional (bi-di) pigs and foam pigs.
- Bi-di pigs must have replaceable components including: polyurethane guide discs, seal discs, spacer discs, tracker, bumper nose, with and without jet function, brushes, and magnets.

Pigging Poles:

 Supply of pigging poles to facilitate pig launching and retrieval from barrels.

Delivery Point:

 All pigs and poles to be delivered to the EACOP warehouse in Tanga, Tanzania.

# 2. Provision of Pigging Support Services:

 Procure and maintain a stock of pig accessories for refurbishment at the service provider's premises, ensuring availability when required.

Used Pig Re-Evaluation:

 Collect used pigs from the EACOP Marine Terminal in Tanga, inspect and re-evaluate for re-use, refurbishment, or scrapping.

Refurbishment of Pigs:

 Replace damaged components with stocked accessories and return refurbished pigs to EACOP.

Scrapping & Disposal:

 Dispose of pigs beyond repair in accordance with EACOP waste management requirements. Technical Support:

- Provide on-call technical support for stuck pig scenarios.
  Training:
- Deliver both practical on-site and refresher training sessions for EACOP personnel on pigging operations.

### A. MINIMUM REQUIREMENTS:

Companies or Organization/local joint ventures expressing their interest are invited to submit documentation of their request with:

- 1. Experience & Capability:
  - Minimum 5 years' proven experience in pigging services or related oil and gas operations.
  - Demonstrated expertise and capacity to deliver the required scope of services.
  - Evidence of similar projects, including supply of pigs and pigging support services.
- 2. Industry Knowledge & Team Competence;
  - Qualified and experienced team with knowledge of pig manufacturing, refurbishment, and operational support.
  - Track record of delivering services to the oil and gas industry.
- 3. Legal & Business Registration;
  - Valid Business License in Tanzania.
  - Certificate of Incorporation and recent BRELA search report (attach copy).
  - Registration with EWURA Local Supplier Service Provider (LSSP) database (or evidence of application).
  - Proof of compliance with Local Content Regulations (2017) and confirmation of 100% Tanzanian ownership.
- 4. Financial Capacity;
  - Proof of registration with Tanzania Revenue Authority (TRA) and valid Tax Clearance Certificate.
  - Evidence of financial capacity, including: Bank confirmation letter and Audited financial accounts for the last three years.
- 5. Quality, Health, Safety & Environment (QHSE);
  - Evidence of a QHSE management system aligned with local and international standards.
  - Relevant certifications, licenses, and registration with HSE regulatory authorities.
- 6. Compliance & Governance;
  - Proof of Anti-Corruption, Anti-Bribery, Compliance, and Human Rights policies.

All Expression of Interests should be submitted in the English Language.

Only the pre-qualified companies will receive, by signing a Non-Disclosure Agreement (NDA), an invitation to bid as a continuation of the call for tender process.
