

REQUEST FOR EXPRESSION OF INTEREST: PROVISION OF FABRIC MAINTENANCE SERVICES REFERENCE NO. REQ-00000932

East African Crude Oil Pipeline (EACOP) LTD ("EACOP LTD") invites experienced and reputable companies or organizations to express their interest in providing Fabric Maintenance Services for the Tanzania perimeter of the EACOP Project during the pipeline operations phase.

The EACOP Project involves the construction and operation of a buried and cross-border pipeline to transport crude oil from Lake Albert area in Uganda to eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani peninsula in Tanga, Tanzania. The length of the pipeline is 1,443 km, of which 296km will be in Uganda and 1,147 km in Tanzania. In Uganda the pipeline will traverse two (2) regions which are Western and Central regions and in Tanzania, eight (8) regions comprising of Kagera, Geita, Shinyanga, Tabora, Singida, Dodoma, Manyara and Tanga, 27 administrative District Councils, and 231 Villages.

BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES:

The selected Fabric Maintenance Contractor shall be responsible for ensuring the preservation, protection, and restoration of all structural components, piping systems, process equipment, and facility surfaces as mandated by EACOP. The overarching objective is to safeguard asset integrity, promote workplace safety, and guarantee compliance with both EACOP-specific requirements and international standards.

This Expression of Interest (EOI) seeks to identify qualified and experienced company to deliver Fabric Maintenance Services. Key Scope Services required include, but not limited to:

- 1. SIP
 - Scaffolding
 - Insulation
- Painting
- 2. PSG
- Piping (including GRE pipes)
- Structures
- Grating
- 3. Industrial Cleaning & Assistance to operations
 - Surface preparation works (hot cleaning, minor excavation)
 - Civil structures (walls, floors, ceilings)
 - · Carpentry (roof, windows, doors, furniture

Resources and Coverage: Deployment of both general labor and technical specialists, including welders, insulators, painters, scaffolders, and civil support staff as needed. Services cover all EACOP operational infrastructure: both onshore and offshore facilities, pipelines, and associated industrial or support buildings.

Compliance and Standards: All activities to be performed using best industry practices for asset integrity, safety, and environmental management. Compliance with EACOP health, safety, environmental and quality requirements is mandatory; adherence to relevant international standards (e.g., ISO, API, OSHA) is expected at all times.

MINIMUM REQUIREMENTS:

Companies or Organization/local joint ventures expressing their interest are invited to submit documentation of their request with:

- Minimum 5 years' proven experience in fabric maintenance services or related oil and gas operations.
- Demonstrated expertise and capacity to deliver the required scope of services.
- Evidence of relevant local or similar service projects.
- Experienced, qualified team with relevant industry expertise and references.
- Valid Business License in Tanzania.
- Certificate of Incorporation and recent BRELA search report (attach copy).
- Registration with EWURA Local Supplier Service Provider (LSSP) database (or evidence of application).
- Proof of compliance with Local Content Regulations (2017) and confirmation of 100% Tanzanian ownership.
- · Proof of registration with Tanzania Revenue Authority (TRA) and a recent Tax Clearance Certificate.
- Evidence of financial capacity, including: Bank confirmation letter and a copy of Audited financial accounts for the last three years.
- Evidence of a QHSE management system aligned with local and international standards.
- Relevant certifications, licenses, and registration with HSE regulatory authorities.
- Proof of Anti-Corruption, Anti-Bribery, Compliance, and Human Rights policies.

Only the pre-qualified companies or local Joint ventures will receive, by signing a Non-Disclosure Agreement (NDA), an invitation to bid as a continuation of the call for tender process.
