



REQUEST FOR EXPRESSION OF INTEREST: SUPPLY OF HEALTH SAFETY AND ENVIRONMENT (HSE) CONSUMABLES - UGANDA. REFERENCE NO. REQ-00000944

East African Crude Oil Pipeline (EACOP) LTD ("EACOP LTD") invites experienced and reputable companies or organizations to express their interest in supplying Health Safety and Environment (HSE) consumables to the East African Crude Oil Pipeline (EACOP) Project.

The EACOP Project involves the construction and operation of a buried and cross-border pipeline to transport crude oil from Lake Albert area in Uganda to eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani peninsula in Tanga, Tanzania. The length of the pipeline is 1,443 km, of which 296km will be in Uganda and 1,147 km in Tanzania. In Uganda the pipeline will traverse ten districts and in Tanzania, eight (8) regions comprising of Kagera, Geita, Shinyanga, Tabora, Singida, Dodoma, Manyara and Tanga, 27 administrative District Councils, and 231 Villages.

BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES

EACOP requires the services of experienced and reputable contractors to supply certified Health, Safety, and Environmental (HSE) Consumables to support the safe operations of the EACOP project. It includes items such as Personal Protective Equipment (PPEs), Hygiene and sanitation supplies, eye-wash stations, minor spill control materials, Isolation Lockout/Tagout (LOTO) materials, confined space and work at height accessories (filter cartridges, clips, tags) etc. All equipment must meet industry-recognized safety standards (such as ANSI, OSHA, or equivalent) and be suitable for use in high-risk environments typically found along oil pipeline corridors. The selected contractor must deliver equipment meeting recognized safety standards, with clear technical specifications, and quality assurance measures.

Provided Personal Protective Equipment (PPEs) will include but not limited to:

- Head protection, Safety helmet fitted with a chin strap, ventilated Comply with applicable UG Standards, EN 397, ANSI Z89.1 or other equivalent international standard.
- Hearing protection, Disposable Ear Plug, Reusable Ear Plug, Earmuff attached to Helmet, Earmuff. Comply with applicable UG Standards, EN 352.2 or other equivalent international standard.
- Face / Eyes protection, Safety Glasses. Comply with applicable UG Standards, EN 166 or ANSI Z87.1 or AS/NZS 1337 or other equivalent international standard Material: Polycarbonate.
- Foot Protection, Safety Shoes / Boots, Comply with UG Standard, EN 345, ANSI Z41 or other equivalent international standard. Standard protective footwear has built-in steel toe caps and be made primarily of leather with non-electricity conductive and reinforced non-slip soles and Stainless steel mid sole for nail proof.
- Flame Retardant Protective Clothing (IEC 61482, NFPA 2112 or equivalent), Coveralls or Combi-Suits with long sleeves, 100% cotton, light Fabric, with reflective striping and ventilations for shirts and trousers with relevant company logos.
- Rainwear, Raincoats / Suits: Consideration must be given to ambient temperatures to prevent heat stress (light weight, breathable, vented, etc.).
- Fire Fighting Clothing and equipment. Comply with EN 469 (2020), EN ISO 20471 or other equivalent international standard.
- Other Addition PPE as required by end users. Fall Protection, Welding Protective Equipment, Chemical Protective Equipment, Respiratory Protection etc.

- Provide a list of branches and or associates in Uganda.
- Provide information on PPE make and current stock and planned inventory for the coming year.

MINIMUM REQUIREMENTS

Companies or Organizations expressing their interest are invited to document their request with:

- Certificate of incorporation/registration and a valid copy of trading/ business License.
- Recent Uganda Registration Services Bureau (URSB) search (attach copy).
- Brief description of experience, expertise, and capacity to deliver the required scope of services.
- Proof of certified personnel/manpower qualified who will be responsible to perform calibration services.
- Minimum of 5 years' proven experience in supply and performing calibration services.
- Proof of registration with Uganda National Bureau of Standards (UNBS) including Beneficial Owners Particulars.
- Proof of valid registration on the National Supplier database maintained by the Petroleum Authority of Uganda.
- Compliance with the Petroleum (Refining, Conversion, Transmission and Midstream storage) (National Content) Regulations, 2016.
- Proof of registration with Uganda Revenue Authority (URA) and valid Tax Clearance Certificate.
- Audited financial accounts for the past three years.
- Evidence of Quality, Health, Safety, and Environment (QHSE) management system compliant with local and industry standards/certificates for ISO 45001:2018, ISO 14001:2015 and ISO 9001:2015.
- Relevant registration/certification with HSE regulatory and certifying bodies (Workplace certificate from the OSH department).
- Signed copies of Anti-corruption, Anti-bribery, Compliance and Human Rights policies.

Companies or organizations which have the ability, capacity, and resources to implement the activities listed above should express their interest by sending an Expression of Interest (EOI) via email, together with the above listed documents through an email to procurement.ug@eacop.com (max. email size 20Mb) on or before 17:00 hours East African Time (EAT) on **18th November 2025**.

Statements of EOI should be no more than twenty (20) pages long.

All Expression of Interests should be submitted in the English Language.

NOTE: EACOP LTD will review and assess the documents provided by companies that have expressed interest in accordance with this EOI and conduct evaluations based on internal criteria to determine which companies will be included in the list of pre-qualified companies. Only the pre-qualified companies will receive, by signing a Non-Disclosure Agreement (NDA), an invitation to bid as a continuation of the call for tender process. EACOP LTD reserves the right at its sole discretion to make the decision to select or reject a company and maintain its decision without having to give reasons to the company concerned.
