PROVISION OF HEALTH SAFETY AND ENVIRONMENT  
(HSE) EQUIPMENT MAINTENANCE AND SERVICES

East African Crude Oil Pipeline (EACOP) LTD ("EACOP LTD") invites experienced and reputable companies or organizations to express their interest in providing maintenance and servicing of Health, Safety, and Environmental (HSE) equipment in support of the EACOP Operations phase.

The EACOP Project involves the construction and operation of a buried, cross-border pipeline to transport crude oil from the Lake Albert area in Uganda to eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale in Hoima District, Uganda, to the Chongoleani peninsula, near Tanga, in Tanzania. The length of the pipeline is 1,443 km, of which 1,147 km will be in Tanzania traversing eight (8) regions, comprising Kagera, Geita, Shinyanga, Tabora, Singida, Dodoma, Manyara and Tanga and 231 Villages.

**BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES:**

This Expression of Interest (EOI) seeks to identify qualified and experienced services companies to supply maintenance, inspection, testing, certification, and servicing of HSE equipment to ensure compliance with regulatory, industry, and EACOP-defined standards during the operations phase of the EACOP project.

The intent is to guarantee the operational readiness, reliability, and regulatory conformance of all covered equipment throughout routine operations and in support of emergency response requirements. The services shall include, but are not limited to:

- Preventive and corrective maintenance of HSE equipment (e.g. firefighting, work-at-height, confined space, gas detection, rescue and personal protective apparatus).
- Regular inspections, functional tests, and certification as per manufacturer/regulatory criteria.
- Prompt mobilization for repairs and emergency service when required.
- Periodic reporting and record keeping for EACOP compliance oversight.

**MINIMUM REQUIREMENTS:**

Companies or Organization/local joint ventures expressing their interest are invited to submit documentation of their request with:

- Brief description of minimum 5 years' demonstratING proven experience in managing similar maintenance programs, provide qualified and certified personnel, and ensure compliance with all national regulatory requirements and recognized international safety standards.
- Valid Business License in Tanzania.
- Certificate of Incorporation and recent BRELA search report (attach copy).
- Registration with EWURA Local Supplier Service Provider (LSSP) database (or evidence of application).
- Proof of compliance with Local Content Regulations (2017) and confirmation of 100% Tanzanian ownership.
- Proof of registration with Tanzania Revenue Authority (TRA) and valid Tax Clearance Certificate.
- Evidence of financial capacity, including: Bank confirmation letter and Audited financial accounts for the last three years.
- Evidence of a Quality, Health, Safety & Environment (QHSE) management system aligned with local and international standards.
- Relevant certifications, licenses, and registration with HSE regulatory authorities.
- Proof of Anti-Corruption, Anti-Bribery, Compliance, and Human Rights policies.
