

REQUEST FOR EXPRESSION OF INTEREST: PROVISION OF TECHNICAL SUPPORT OF IVMS IN VEHICLES SERVICE FOR EACOP LTD IN TANZANIA REFERENCE NO. REQ-00000965

East African Crude Oil Pipeline (EACOP) Ltd invites experienced and reputable companies or organisations to express their interest in undertaking the Provision of Technical Support of IVMS in Vehicle Service for the East African Crude Oil Pipeline (EACOP) Project.

The EACOP Project involves the construction and operation of an underground and cross-border pipeline to transport crude oil from the Lake Albert area in Uganda to the eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani Peninsula in Tanga, Tanzania. The length of the pipeline is 1,443 km, of which 296 km will be in Uganda and 1,147 km in Tanzania. In Tanzania, the pipeline will traverse eight (8) regions comprising Kagera, Geita, Shinyanga, Tabora, Singida, Dodoma, Manyara and Tanga, 27 administrative district councils, and 231 villages.

DESCRIPTION OF THE SCOPE OF THE SERVICES:

- Supply of new/reconditioned PowerFleet Mix IVMS Tracking Unit, Camera & Fatigue Camera.
- Routine mechanical inspection and servicing of IVMS mounting assemblies, wiring harnesses, connectors, and enclosures.
- On-vehicle mechanical fault diagnosis and corrective repairs (vibration, shock, water ingress, mounting failure).
- Removal and refit of IVMS units for mechanical repair, testing, and re-installation.
- Replacement of mechanical accessories and consumables (mounting brackets, gaskets, seals, cable glands, fasteners).
- Condition-based recommendations for corrosion protection, cable routing improvement, and secure mounting solutions.
- Support for mechanical integration when vehicles are serviced (coordination with electrical/IT teams as required).
- Emergency mechanical response within the agreed SLA for vehicles critical to operations.

MINIMUM REQUIREMENTS:

Companies or organisations expressing their interest are invited to document their request with:

- Brief description of experience, expertise, and capacity to deliver the required scope of services.
- Demonstrated experience in Technical Support of vehicle-mounted telematics or IVMS hardware.
- Quality assurance procedures and warranty terms for mechanical repairs.
- Insurance cover (public liability and professional indemnity) and proposed service level agreement (SLA) terms.
- Details of similar projects demonstrate the team's qualifications, availability, regional knowledge, and relevant experience.
- Profile of key personnel to be involved in the provision of services including personal certifications as necessary and level of qualifications, and experience and capacity to deliver the required services in a major capital oil and gas project.
- Company profile including an organizational structure.
- Valid Business License.
- Copy of Certificate of Incorporation or business registration.
- Evidence of appropriate sector-specific licenses or permits, if required, from relevant regulatory authorities in Tanzania.
- Proof of Registration with the EWURA Local Supplier Service Provider (LSSP) database or an approved application at the time of submission of the response to this expression of interest is strongly recommended.
- Compliance with Local Content Regulations, 2017 and Local Company definition.
- Proof of registration with the Tanzania Revenue Authority (TRA) and Tax Clearance Certificate for the latest year available (2025).
- A copy of the most recent official search report from the Business Registrations and Licensing Agency (BRELA).
- Financial capacity to deliver the services required, including submission of financial accounts for the past three years.
- Evidence of a QHSE Management system, organization, and process in compliance with applicable Local and Industry standards for similar works.
- Proof of Anti-corruption, Anti-bribery, Compliance and Human Rights policies.
