

REQUEST FOR PROPOSAL/EXPRESSION OF INTEREST: SUPPLY OF HEALTH, SAFETY, AND ENVIRONMENT (HSE) CONSUMABLES – TANZANIA REFERENCE NO. REQ-REQ-00000945

East African Crude Oil Pipeline (EACOP) LTD ("EACOP LTD") invites experienced and reputable companies or organizations to express their interest in supplying Health, Safety, and Environment (HSE) consumables for the Tanzania perimeter of the EACOP Project during the pipeline operations phase.

The EACOP Project involves the construction and operation of a buried and cross-border pipeline to transport crude oil from Lake Albert area in Uganda to eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani peninsula in Tanga, Tanzania. The length of the pipeline is 1,443 km, of which 296km will be in Uganda and 1,147 km in Tanzania. In Uganda the pipeline will traverse two (2) regions which are Western and Central regions and in Tanzania, eight (8) regions comprising of Kagera, Geita, Shinyanga, Tabora, Singida, Dodoma, Manyara and Tanga, 27 administrative District Councils, and 231 Villages.

BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES:

This Expression of Interest (EOI) seeks to identify qualified experienced and certified contractors to supply Health, Safety, and Environmental (HSE) consumables essential for safe project operations along the pipeline corridor. The scope covers delivery of high-quality, industry-compliant items suitable for use in oil and gas construction and operational environments across Tanzania.

Supplied item shall include, but is not limited to:

1. Personal Protective Equipment (PPE):

- Head protection (safety helmets with chin straps, ventilated, compliant with TZ Standard, EN 397, ANSI Z89.1 or equivalent).
 Hearing protection (disposable and reusable earplugs, helmetattached earmuffs, compliant with TZ Standard, EN 352.2 or equivalent).
- Face and eye protection (polycarbonate safety glasses, compliant with TZ Standard, EN 166, ANSI Z87.1, AS/NZS 1337 or equivalent).
- Foot protection (safety shoes/boots with steel toecaps, anti-slip/ stainless steel midsoles, compliant with TZ Standard, EN 345, ANSI Z41 or equivalent).
- Flame retardant coveralls and combi-suits (100% cotton, reflective striping, light and ventilated material, compliant with IEC 61482, NFPA 2112 or equivalent).
- Rainwear (lightweight, breathable, vented, suitable for ambient conditions).
- Firefighting clothing and equipment (TZS 1303–1305:2011(E), EN 469 or equivalent).
- Specialty PPE as required (fall protection, welding PPE, chemical PPE, respiratory PPE, etc.), as specified by end users.

Other HSE Consumables and Accessories include, but is not limited to:

- · Hygiene and sanitation supplies.
- · Eye-wash stations.
- Minor spill response kits.
- Isolation/Lockout-Tagout (LOTO) devices.
- Confined space and work-at-height accessories (filter cartridges, tags, clips).

 All products must comply with recognized Tanzanian/ international safety standards (e.g., ANSI, OSHA, or equivalent), and be supported by clear technical specifications, batch certification, and supplier quality assurance documentation etc.

3. Contractor Requirements must also:

- Provide details and locations of company branches and associates within Tanzania.
- Submit information on PPE brands supplied, current inventory, and planned stock levels for the next 12 months.

MINIMUM REQUIREMENTS:

Companies or Organization/local joint ventures expressing their interest are invited to submit documentation of their request with:

- Brief description of minimum 5 years' proven experience, expertise, and capacity in delivering similar services, preferably within the oil & gas industry.
- Valid Business License in Tanzania.
- Certificate of Incorporation and recent BRELA search report (attach copy).
- Registration with EWURA Local Supplier Service Provider (LSSP) database (or evidence of application).
- Proof of compliance with Local Content Regulations (2017) and confirmation of 100% Tanzanian ownership.
- Proof of registration with Tanzania Revenue Authority (TRA) and valid Tax Clearance Certificate.
- Evidence of financial capacity, including: Bank confirmation letter and Audited financial accounts for the last three years.

 The last three years.
- Evidence of a Quality, Health, Safety & Environment (QHSE) management system aligned with local and international standards.
- Relevant certifications, licenses, and registration with HSE regulatory authorities.
- Proof of Anti-Corruption, Anti-Bribery, Compliance, and Human Rights policies.

Companies or organizations which have the ability, capacity, and resources to implement the activities listed above should express their interest by sending an Expression of Interest (EOI) via email, together with the above listed documents through an email to procurement.tz@eacop.com (max. email size 20Mb) on or before 17:00 hours East African Time (EAT), on 20th November 2025. All Expression of Interests should be submitted in English Language.

Note: EACOP LTD will review and assess the documents provided by companies that have expressed interest in accordance with this EOI and conduct evaluations based on internal criteria to determine which companies, or local Joint ventures will be included in the list of pre-qualified companies or local Joint ventures. Only the pre-qualified companies or local Joint ventures will receive, by signing a Non-Disclosure Agreement (NDA), an invitation to bid as a continuation of the call for tender process. EACOP LTD reserves the right at its sole discretion to make the decision to select or reject a company or local Joint ventures and maintain its decision without having to give reasons to the company or local Joint ventures concerned.
