(EACOP = East Africa Crude Oil Pipeline Project. EITS = Electrical, Instrumentation, Telecommunication and Security Systems.)

SCOPE OF SERVICES FOR STORAGE FACILITIES: CITY STORAGE FACILITY (CENTRAL WAREHOUSE) **General Requirements**

- Location: Easily accessible from major roads; proximity to City or Central hub in Kampala preferred.
- Size: Minimum 100m² scalable based on project load
- 70m2 for normal materials and 30m2 for electronic parts and tools with controlled HVAC system.
- Storage Management Software System and Shelves Manpower to control/manage storage
- Able to provide weekly report on storage status
- Security: 24/7 surveillance (CCTV)
- Visitor and Contractor Management System
- Controlled access (biometric or card-based)
- Perimeter fencing and lighting
- Environmental Controls:
- Ventilation and temperature control for sensitive equipment
- Fire suppression systems (sprinklers, extinguishers)
- 0 Pest control measures
- Operational Features
- Inventory Management System: Digital tracking of incoming/ outgoing items.

- Loading/Unloading Area: Covered bays for trucks and forklifts. Staff Facilities: Office space.
- Power Backup: Generator or UPS for critical systems.
- Storage Specifications
- Racking Systems: Adjustable shelving for tools, spare parts, and consumables
- Compliance: Adherence to local safety and environmental regulations.
- HVAC system for partial area (30m2)

2. SITE STORAGE FACILITY (TEMPORARY OR SEMI-PERMANENT) **General Requirements**

- Location: Within secure perimeter of the site, close to work zones across corridor of the pipeline i.e. MCPY's and PS's. 1 container per specified location.
- Size: 1No. 40 FT length container and 3No. 20FT length containers.
- Security:
- Lockable containers or prefabricated units Lighting for night visibility
- Operational Features
- Quick Access: Layout optimized for daily use by site teams. Weather Protection: Waterproof roofing and raised flooring.
- Signage & Labelling: Clear identification of zones and materials.
- Storage Specifications
- Tool Lockers: Secure cabinets for hand tools and power tools.
- Material Bays: Segregated areas for steel, cables, pipes, etc.
- Additional Considerations
- Mobility: Use of mobile storage units or containers for shifting needs.
- 0 Compliance: Adherence to local safety and environmental regulations.
- Integration: Sync with central inventory system for tracking.

- MINIMUM REQUIREMENTS: Certificate of Incorporation, URSB, NSSF, URA (TIN, VAT, TCC) Registrations
- Proof of registration on the Petroleum Authority of Uganda's National Supplier Database (NSD).
- Compliance with the Petroleum National Content Regulations, 2016, definition of Ugandan Company Company Profile, Audited financial statements for the past 3 financial years and a Letter from your Banker(s).
- At least 5 years of demonstrable experience and financial capacity in delivering such services.
- Ensure submission of all relevant statutory permit/license, certificate & Registration copies to facilitate the requested scope of work for Tools and
- Evidence of a Quality Health, Safety, and Environment (QHSE) management system including OSHA
- Valid ISO: ISO 9001, ISO 14001, ISO 45001 or equivalent (as applicable).
