East African Crude Oil Pipeline (EACOP) Ltd invites experienced and reputable companies or organizations to express their interest in additional detailed design and implementation of a community awareness program for EACOP affected communities.

The EACOP Project involves the construction and operation of an underground and cross-border pipeline to transport crude oil from the Lake Albert area in Uganda to the eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale, Hoima District in Uganda to the Chongoleani peninsula in Tanga, Tanzania, crossing eight regions – Kagera, Geita, Shinyanga, Tabora, Singida, Dodoma, Manyara and Tanga, 27 administrative district councils and 231 villages.

BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES:

EACOP is seeking to implement a 12-month Gender-Based Violence and Harassment (GBVH) and Sexual and Reproductive Health and Rights (SRHR) awareness campaign along the project corridor in Tanzania. The purpose of the campaign is to reduce GBVH and SRHR-related risks among the Project workforce and Project-Affected Communities (PACs) by promoting knowledge, attitudinal change, and positive behaviors.

The selected partner will design, plan, and deliver culturally relevant, participatory, and engaging interventions, including community radio programs, edutainment (drama and theatre), IEC materials, social media engagement, community dialogues, school sensitization, and integrated HIV/STI testing outreaches. Activities will also include distribution of sexual and reproductive health (SRH) resources, such as condoms and family planning kits, to high-risk groups and vulnerable populations. Capacity building for local performers, opinion leaders, and project personnel will ensure sustainability and compliance with safeguarding standards.

Monitoring, evaluation, and reporting will track progress, assess behavioural change, and document lessons learned, ensuring the campaign delivers measurable impact while prioritizing the health, safety, and well-being of women, girls, and other vulnerable groups.

MINIMUM REQUIREMENTS:

Organizations expressing their interest are invited to submit their request with:

- Details of design and implementation of similar projects preferably within EACOP regions including key elements of the projects, number of beneficiaries and overall value.
- Evidence of previous contracts of similar scope, including reference letters or completion certificates from at least three (3) reputable clients within the past five years.
- Profiles of key personnel proposed for this engagement, including their qualifications, relevant experience, and any applicable certifications.
- Company profile including an organizational structure.

- Valid Business License.
- Certificate of Incorporation and recent BRELA search.
- Valid Tax Identification Number (TIN) and VAT registration certificate.
- Tax Clearance Certificate for the most recent year.
- Evidence of appropriate sector-specific licenses or permits, if required, from relevant regulatory authorities in Tanzania.
- Demonstration of compliance with the Petroleum (Local Content) Regulations, 2017, including but not limited to:
 - Evidence of Tanzanian ownership/shareholding.
 - Evidence of employment of Tanzanian nationals.
- Application for registration with the EWURA Local Supplier Service Provider (LSSP) database at the time of submission of the response to this expression of interest is strongly recommended.
- Financial capacity to deliver the services required including submission of financial accounts for the past three years.
- Proof of Anti-corruption, Anti-bribery, Compliance and Human Rights policies.
- Proof of relevant registration/certification with HSE regulatory and certifying bodies.
- Evidence of a QHSE management system, organization and process in compliance with applicable local and industry standards for similar works.
- Proof of appropriate licensing from relevant authorities.

Companies which have the ability, capacity, and resources to implement the activities listed above should express their interest by sending an Expression of Interest (EOI) via email, together with the above listed documents through an email to **procurement.tz@eacop.com** (max. email size 20MB) on or before **17:00 hours** East African Time (EAT), on **25th February 2026**.

All Expression of Interests should be submitted in English Language.
