The EACOP project involves the construction and operation of a buried, cross-border pipeline to transport crude oil from the Lake Albert area in Uganda to the eastern coast of Tanzania for export to international markets. The pipeline will run from Kabaale in Hoima District, Uganda, to Chongoleani, Tanga Region in Tanzania. The length of the pipeline is 1,443 km, of which 1,147 km will be in Tanzania.

#### BRIEF DESCRIPTION OF THE SCOPE OF THE SERVICES

#### SCOPE OF WORK:

- The Education and Training Services provider shall implement E.A.L.S. Contractor Training and Capacity Building Program as per E.A.L.S. Contractor obligations.
- Interaction with Training Stakeholders: Education Institutions (Bandari College, Vocational Educational training Authority (Morogoro, Moshi), Dar es Salaam Maritime Institute (DMI) and National Institute of Transportation), EACOP Company, E.A.L.S. Partners (incl Sub-contractors), E.A.L.S. Contractor Training/Capacity Building Teams
- Develop a Train the Trainer Implementation Program that covers and measures 690 manhours on: (1) Lifting Technologies and Rigging in MLC context, (2) Road Transport Management Systems in MLC context, (3) H3SE Training in MLC context, (4) Driving and Defensive Driving, (5) Trailer deployment (wear and tear, maintenance, lashing) in MLC context. Support to education institutions in terms of curriculum development, customised content, tools, and equipment as needed.
- Develop an implementation program to deliver 630 manhours at specified industry enhancement centres
- Trainings to be delivered by certified and accredited trainers. Trainings to be certified and accredited as applicable.
- KPI Reporting: produce reports on a scheduled basis in line with Local Content requirements and obligations prescribed in the Construction Combined Plan (CCP)
